### Budget, Taxes, Rural Internet On The Agenda

As I write this, the legislative session is two-thirds complete. The last constitutional day of the regular session is March 8, 2018. The expectation is that the legislature will finish on time this year. The House of Representatives has passed 317 bills so far. Now all of those bills must go to the Senate and vice versa.

At this point in the session, much of the focus is on the budget and proposals for new taxes. Last week, the Washington State Economic and Revenue Forecast Council released its quarterly state revenue forecast. Because of a strong economy in much of the state, the revenue forecast has been increased by \$647 million for the 2017-19 budget cycle and over \$1.3 billion over the next four years. This level of growth has not been seen for over a decade. Most legislators acknowledge that most of the economic growth is in the greater Puget Sound region, while much of rural Washington has a more stagnant economy.

In spite of the good news on the revenue front, multiple tax bills are still alive and appear to be moving. Governor Inslee's carbon tax proposal would create a new tax of \$10 per metric ton of carbon emissions beginning in 2019. It would increase \$2 a ton per year in 2021 until the price reached a cap of \$30 a ton. It would increase the gas tax by 30 cents a gallon, increase electricity rates by 17 percent and result in higher prices for fuel, fertilizer, transportation and processing. Rural residents would pay the most by virtue

of the fact that they must drive farther to reach basic services such as grocery stores and doctors.

Another bill would create a low carbon fuel standard which amounts to a hidden gas tax. Lower carbon fuels reduce fuel efficiency, resulting in increasing farm production costs. If this bill and the carbon tax both pass, Washington residents would face 35 to 45 cents more per gallon at the pump — on top of the 68 cents we already pay in federal and state gas taxes.

Another tax proposal, House bill 2967, would impose a new capital gains income tax. And Senate bill 6609 would revoke the sales tax exemption for pesticides, fertilizer and numerous other items.

It's not all bad news for rural Washington. Two bills focused on bringing high-speed internet to rural areas are still alive and moving. House bill 2664 sponsored by Rep. Mary Dye of Pomeroy would extend wholesale telecommunications authority to all public ports. "This is a great use of public-private partnerships without having to use state tax dollars," said Dye.

Senate bill 5935, sponsored by Senator Tim Sheldon of Potlach would designate high-speed broadband service for all of Washington as a high-priority state concern. It would follow federal standards in setting a target for high-speed service and would also create a state Office of Broadband Access to coordinate with local governments.

Stay tuned, much could happen yet before this legislative session winds to a close.

### NE Washington Wolf-Livestock Grant Board Awards Five Grants For Wolf-Livestock Projects

The Northeast Washington Wolf-Livestock Grant Board has completed their evaluation process of the seven applications received for the Northeast Washington Wolf-Livestock Management Grant.

In 2017, the state Legislature allocated \$300,000 to this grant for the 2017-19 biennium. The funding is intended to create a community-based approach to provide assistance for projects related to nonlethal methods of deterring wolves from livestock in Okanogan, Ferry, Stevens, and

Pend Oreille counties. Individuals and nonprofit, community-based organizations are eligible for these grants.

Last year, in consultation with area legislators and NE Washington conservations districts, WSDA Director Derek Sandison appointed four members to the Northeast Washington Wolf-Livestock Grant Advisory Board. All members are knowledgeable about wolf depredation issues and approaches. The advisory board met in January to review and select the projects to receive funding and advise WSDA on the expenditures of the northeast Washington

wolf-livestock management grant funds. WSDA's role is to ensure projects selected to receive funding are in compliance with state law and regulations.


The Board has awarded five grants totaling \$257,001 for projects using nonlethal deterrence and nonlethal wolf-livestock management techniques including fencing, range-riders, fladry, and so forth.

#### Broadband & telecomm service

E2SSB 5935

Creates the governor's office on broadband access within the department of commerce, and with the mission of improving economic vitality, health care access, and education through greater access to broadband services. Requires the office to: (1) In collaboration with the utilities and transportation commission, the office of the chief information officer, and the community economic revitalization board, serve as the coordinating body for public and private efforts to ensure statewide broadband access and deployment; (2) Be responsible for all matters regarding the adoption of statewide broadband access and deployment; (3) Establish a competitive grant program to assist qualified local governments and tribes to build infrastructure for open access, high speed broadband services; (4) Study taxes imposed on the capital costs associated with providing retail broadband service, including sales and use taxes; (5) Develop a small cell facility deployment permitting model ordinance for cities and towns; and (6) Consult with cities, counties, and service providers when developing the model ordinance. Authorizes the office to convene an advisory group to: (1) Make recommendations on developing a statewide rural broadband strategy to ensure broadband access statewide by January 1, 2026; and (2) Conduct a gap analysis on the deployment of broadband services in underserved and unserved areas of the state. Creates the broadband access account and requires expenditures from the account to only be used for the expansion of broadband access.

Authorizes the department of agriculture to: (1) Take actions necessary to cooperate in implementation of the produce safety rule, including entering into cooperative agreements with the United States food and drug administration, conducting compliance verification activities, enforcing regulatory compliance, and accepting federal funding to carry out the activities; (2) Cooperate with the United States food and drug administration in implementation of the produce safety rule only to the extent that the department receives federal funding for the activities; and (3) Establish a voluntary program for farms exempt or partially exempt from the produce safety rule to verify that the farms comply with the rule. Exempts the following from disclosure under the public records act: Information obtained from the federal government or others under contract with the federal government or records obtained by the department of agriculture. Creates a produce safety account in the agricultural local fund.



### **Grange History, Ritual And Programs Included In Youth Trivia Challenge**



The Francis McDowell Trivia Challenge is required for participation in many of our National Grange Youth Programs. The trivia challenge includes questions such as:

- The influence of the National Grange was significant in the passage of what Act in 1917 that provided further for vocational and agricultural education?
- The use of which Grange emblem teaches us perseverance in overcoming obstacles?
- · Who may install the officers of a Subordinate Grange?
- Complete the sentence, "Before literature existed, before governments were known, ...."

These questions are included in the 2018 trivia challenge, which is a part of the National Grange Youth Achievement Awards Program. Details on the awards can be found in the WA State Grange Youth Program Guide, available on the youth page of the State Grange website: www.wagrange.org. Also available is an application form for the awards program. Each youth chairman should simply print out the application form and circle the awards the individual member

qualifies for. The levels on each award can be earned in any order.

Examples of what qualifies for youth achievement awards are as

- William Saunders Agricultural Achievement Award: visit with a farmer and then write an essay about what you learned about running a farm, prepare an exhibit for a county or community fair, working on a Grange display at your local or state fair, develop an agricultural enterprise, organize a mutual event with your local FFA or 4-H chapter.
- John Trimble Legislative Achievement Award: plan a legislative night for your local Grange, research an important community issue and write a resolution for consideration by the State Grange; serve as a delegate to the State Grange Session, participate in a Legislative Day at your state house.
- Drill Achievement Award: participate in a drill presentation at the subordinate or Pomona Grange, participate in a drill at state convention of Grange camp, participate in a drill at the Regional Youth Conference, create an original drill for the Grange at any level, prepare a workshop on drills.
- John Thompson Achievement Award: research on the degrees and write an essay about how you can apply the lessons to your daily life, memorize the opening ceremony of a Grange meeting,

organize a workshop on ritual, serve as a member of the State Youth Officer Team or National Youth Officer Team.

- Oliver H Kelly Public Speaking Achievement Award: present a speech at your subordinate or Pomona Grange; participate in the Grange Public Speaking Contest, prepare a workshop on public speaking for your Grange.
- Francis McDowell Trivia Challenge: complete the trivia challenge and score at least 75%.
- Aaron Grosh Mentoring Award: assist with Junior Grange meetings and activities, serve as a JG leader, lead a JG service project, be a JG camp counselor, assist with state and/or national session JG activities.
- Caroline Hall Achievement Award: share a specific talent with your Grange, participate in a community service project, enter a talent contest, organize a Grange service project, organize a fundraising event for a charity.
- William Ireland Deaf Awareness Achievement Award: learn the manual alphabet, develop a deaf awareness display, participate in the sign-a-song contest.

Applications for all youth achievement awards can be sent to the State Youth Director at any time, but no later than August 15 for this year's awards. We hope to have many award recipients in 2018!

## **Beat Winter Blues With Help From Vitamin D**

Cooked with wholesome ingredients like milk, chicken and potatoes and topped with bacon and green onions, it's an easy and delicious addition to your weekly meal rotation. #### **Pressure Cooker Corn Chowder**

Servings: 12

6 slices (6 ounces each) thick-cut bacon, chopped

1 small yellow onion, diced

3 cloves garlic, minced

1 pound boneless skinless chicken breast, diced

1 bag (16 ounces, about 3 1/3 cups)

frozen corn kernels

4 cups chicken broth

1 pound unpeeled or peeled Yukon Gold potatoes, cut into 1/4-1/2-inch chunks

1/2 teaspoon kosher salt, plus additional, to taste

1/2 teaspoon coarsely ground black pepper, plus additional,

2 tablespoons cornstarch

1 1/2 cups fat-free milk

2-3 green onions, sliced (optional)

1 tablespoon heavy cream or half-and-half (optional)

Heat large skillet over medium-high heat. Add chopped bacon and cook until crispy. Using a slotted spoon, transfer cooked bacon to paper towel-lined plate and pour off all but 1 tablespoon bacon fat.

Return skillet to stove. Add onion and garlic; sauté 2 minutes, stirring frequently. Add diced chicken and frozen corn; sauté for an additional 3 minutes, stirring often.

Remove skillet from heat and transfer contents to pressure cooker. Add chicken broth, potatoes, salt and pepper. Close and seal pressure cooker, making sure the vent is in the sealed position. Cook on high 8 minutes

While the chowder cooks, make a slurry by whisking cornstarch (or flour) into milk. Set aside.

When done, remove pressure cooker from heat. Allow pressure to release on its own or carefully quick-release pressure after a few minutes. Stir in the cornstarch-milk slurry. Cover and allow chowder to thicken for 10-15 minutes before serving.

Portion soup into bowls and generously top with bacon. Garnish with green onion and cream or half-and-half, if desired. Season with additional salt and pepper, to taste.




