

BEEvesting is a local initiative raising awareness of pollinators' importance to our health and making the information and tools for pollinator conservation bring residents, farmers and businesses together encouraging everyone to further understand local environmental issues, food systems and climate challenges. Free rentals of native mason bees and their nesting boxes were provided to local farmers and growers, improving pollination of local crops and the expansion

of native bee populations in the Sammamish Valley.

Mason bees don't sting and are an easy, native, worry-free pollinator for any location, not just farms. The Sammamish Valley Grange and their BEEvesting partners provide expert local resources for members of the community to develop a pollinator conservation habitat for their unique area. 

I am not going to demand payment on time, realizing that many Granges are struggling financially. While we are also concerned about finances at the State Grange level, we certainly understand and are willing to work with any Grange who may need extra time to pay their quarterly dues payment. If you find your Grange in this precarious position, give us a call and we will work with you to get your Grange through this difficult time.

I am also receiving telephone and email messages about when Granges can reopen and begin

their activities. My best advice is that you follow the reopening process for your county. When your county gets to Phase 3 of the Governor's reopening plan, you may have social events with 50 or less persons. Phase

4 will allow us to go beyond the 50 person limitation. We certainly hope to be in Phase 4 well before the October convention dates.

Some counties are already in Phase 2 and will be moving to Phase 3 in the near future. I suspect some counties may continue in Phase 1 for a bit longer. I ask all Grange members to be patient as we reopen our Granges to the community.

As we do reopen our Granges, we may need to do our activities differently than in previous times. Keep an open mind as you make decisions regarding the future of your Grange. Continue to be creative in solving the problems facing our Granges. The opportunity is waiting for our response in how we meet the needs of our communities and to establish relationships that will build the partnerships and cultivate the connections. With careful thought and creative planning, we can build a stronger Grange in every community across the state!

Looking Ahead To The November Election And More

In last months column, I reported on bills that passed the legislature and items that were included in the budget. Shortly after that writing, Governor Inslee vetoed many of those bills and budget items.

Among the items vetoed were:

• a work group intended to update the Growth Management Act (GMA)

• a work group to study the design and use of the state water trust, water banking, and water transfers

• a pilot program to reimburse farmers for purchasing compost from facilities with solid waste handling permits.

• funding for the soil health initiative (The policy bill directing the Department of Agriculture, the Conservation Commission and Washington State University to coordinate on creating a soil health baseline and developing best management practices for improving soil health remains in place.)

• ESSSB 6518 regarding the insecticide chlorpyrifos, was vetoed in its entirety to save money.

With the Corona Virus pandemic in full swing and the economy in free fall, legislators are looking for ways to help businesses, and get both workers and the economy going again. The impact on next years operating budget is expected to be staggering. Agencies will be asked to propose budget cuts.

Looking ahead to the November election

This November, all statewide elected officials will be on the ballot along with all 98 members of the state House of Representatives and one-half of the state Senate. Since it is a presidential election year voter turnout is expected to be high. So far, only one sitting statewide elected official has announced retirement, Lieutenant Governor Cyrus Habib. One member of the Washington congressional delegation, Congressman Denny Heck, is stepping down. Congressman Heck will run for Lieutenant Governor.

Twelve House members and four Senators have announced that they will not seek reelection. Several of them will run for other seats. Expect more announcements before filing week which is May 11-15.

Take Action Now! Help Save The USPS

Grange members are concerned about the future of United States Post Office mail delivery especially to rural routes. The Postal Service has been running on a deficit budget supported bygovernment loans in recent years. Due to the COVID-19 pandemic, USPS now projects a 50% drop in business and revenues. While the National Grange has long supported a self-sufficient Postal Service, no business can survive such a loss without emergency funding.

The Postal Service is fundamental in this time of emergency. It delivers prescriptions, household and business staples, groceries,

meals to rural school children, Personal Protective Equipment, greeting cards and personal correspondence to bridge social distancing.

The House of Representatives passed another stimulus package (HEROES Act) on May 15 that added \$25 billion to make up for lost USPS revenue. This legislation now goes to the Senate for its consideration in June. Grange members are urged to voice their support for emergency Postal Service funding directly to their U.S. Senators by June 1.

Writing Resolutions

Each and every Grange member can take an active part in policy development by writing resolutions. If members are concerned about an issue or the way the Grange is conducting operations, writing an effective resolution is the first step toward change. Take time to consider issues that will make a difference in members' lives. Think about how realistic results can be achieved. Discuss ideas at Grange meetings, and consider input from all members. Prior to finalizing a resolution, have someone, other than the writer, read it aloud to the group to check for clarity, wording and sentence structure. Please don't use abbreviations.

KNOW YOUR FACTS: Identify the problem. It is essential that the writer has a clear understanding of the subject matter. Before writing a resolution, check current Grange Policy (in the annual Legislative Handbook). It is important to know what the existing policy is in order to know what portion needs to be changed. It is also important to know how the law reads. Resolutions are much more effective when they are clear about what needs to be changed. Resolutions that inadvertently include inaccurate information can damage the credibility of the organization. The Washington State Grange office is available to assist with background research on existing laws and policy.

STATEMENT OF ACTION: The resolution must clearly state the desired action to be taken and who is to act. Consider the goal of the resolution, what are the intended results? What course of action is required for an acceptable solution?

CONTACT PERSON: Each resolution must include the name and daytime telephone number of one or more contact persons who are knowledgeable about the issue. This will assist the legislative department in preparing background information for the convention committee.

FISCAL IMPACT: If the resolution relates to Grange law or Grange activities and would cost money to implement, a fiscal impact statement must be prepared showing the cost of implementation. It is important that such resolutions come in early so the Executive Committee can review the cost estimate prior to convention. This statement of cost may be on a separate sheet of paper from the actual resolution.

SEND TO: Resolutions should be sent prior to deadline to the State Grange headquarters in Olympia.

RECOMMENDED FORMAT

- 1. Title Should clearly reflect the issue.
- 2. Problem statement Clearly state the problem and why it is

Carrot Cake

- 2 1/4 cups flour
- 1 teaspoon baking soda
- 1/2 teaspoon salt
- 1 teaspoon cinnamon
- 1/2 teaspoon baking powder
- 1 cup vegetable oil
- 1 1/4 cups sugar
- 3 eggs
- 1 1/2 cups carrots, shredded
- cup crushed pineapple with juice
- 2/3 cup walnuts

Frosting:

1

- 2 packages (8 ounces each) cream cheese
- 3/4 cup butter, softened
- 1 teaspoon vanilla extract
- 5 1/2 cups powdered sugar

Heat oven to 350 F. In large bowl, sift flour, baking soda, salt, cinnamon and baking powder. In mixing bowl, cream together oil and sugar. Add eggs one at a time. Gradually add in carrots and crushed pineapple. Add dry mixture to wet ingredients and beat until smooth. Fold in walnuts.

Pour batter into two lightly greased 8-inch round cake pans and bake 25-30 minutes, or until knife inserted in center comes out clean. Allow cakes to cool completely. Remove cakes from pans and slice off tops to level cakes.

COVID-19 Pandemic Provided Goldendale Grange Chance To Assist School District


Goldendale Grange #49 had the pleasure of working with Goldendale School District during spring break. Our local Schools have been in lock down since March 16, due to COVID-19. They traditionally provide "in need" students a "Care Package" during spring break. With our schools closed and with a limited staff, they needed help. A dedicated group from the Grange and community volunteered to assist the school in preparing 150 care packages. We agreed to the challenge Tuesday afternoon, realizing we only had until Thursday afternoon at 4:30 to deliver. Leaving only 48 hours for this project to come together. Our first concern, the school district, had limited products available. Each food box would need supplies for twelve meals, 3 breakfast and three lunches for two students - 1800 total meals. The shelves of both Goldendale grocery stores were essentially empty. Not, a good start to our project when our nearest big box store is 35 to 70 miles away. Aimee Waddell, Bette Wilde and Lori Klug spent Wednesday morning gleaning product from stores as far away as Yakima and Portland. To add to the challenge, most big box stores limited the number of items we could purchase even though we had letters from "The City of Goldendale" and "Klickitat County Emergency Services" requesting larger quantities. Our determined buyers persevered, by early afternoon they were back at the Grange Hall breaking bulk packages into individual serving. The process of stuffing boxes at the Grange started Thursday morning at 5 a.m. Project was successfully completed by 4:30 and delivered with time to spare. Goldendale School district paid for the product used, we provided all the labor.
