Chimacum Grange Becomes Vaccination Site

As the Covid pandemic spread in early 2020 Chimacum Grange canceled all gatherings at the Grange hall. Since then the board has tried to find ways the hall could be used to help the community deal with the virus. As vaccines became available the Tri-Area Pharmacy in nearby Port Hadlock was setting up to give the inoculations but didn't have the space to do so in their pharmacy. The Chimacum

Grange board heard about this and immediately offered the use of the Grange hall for vaccinations. As this is written in late February over 1200 Jefferson Co. residents have received their shots at the Grange, and the hall will be available for this as long as it's needed. While getting the hall prepared for this it was discovered that the old propane furnace heating the vaccination area was defective

and not repairable. Fortunately a local heating contractor was able to jump on it and replaced the furnace during the first day of vaccinations. It was quite a scene with shivering volunteers from the Bainbridge Prepares Medical Reserve Corp vaccinating people as the furnace was replaced. Reminder, An A Update and Some Thoughts on Leadership

For many of our Granges, this past year has meant few or no meetings, virtual meetings or just some phone calls. As the pandemic situation improves and vaccinations are becoming more available, we will probably begin to come together in-person again. As that happens, it might be a good time to think about Grange and what it means to you and your community. Do you need a reboot? Have you lost contact with others you normally associate with? I recently read a short article about Leadership that I am going to share with you because I believe Leadership is an integral aspect of our organization.

Answering Yes to These 5 Questions Means Your Leadership Skills Are Better Than You Think

Good leaders understand the importance of prioritizing the interests of those they are leading over their own. This is no easy task, even for the most accomplished leader. But it works because it inspires people to a higher purpose. To evaluate and reflect on where you stand as a leader, and whether

you are fit for the role, consider measuring your leadership skills against the high bar of the following five questions.

1. Are you open to feedback?

Many autocratic managers view feedback as a threat to their power, self-worth, and position, which explains why they are opposed to it and often react fearfully and defensively to feedback.

Great leaders, on the other hand, view feedback as a gift to improve their leadership so they can serve others and their mission better. They value truth and honesty and diverse perspectives for bettering themselves and their businesses. Even when feedback is negative, it prompts an exercise in curious exploration to find out where things went wrong so that it doesn’t happen again.

2. Is your work environment psychologically safe?

Research by Amy Edmondson of Harvard indicates that when leaders foster a culture of safety – where employees are free to speak up, experiment, give feedback, and ask for help – it leads to better learning and performance outcomes.

When psychological safety is absent, fear is present. And fear is detrimental to achieving a company’s full potential. We just can’t be engaged or innovative when we are afraid. Some subscribe to the notion that fear is a motivator in the short-term, but what fear does is kill trust – the ultimate demotivator.

3. Do you share the decision-making process?

Traditionally, an autocratic style of management has been effective in getting results. But the nature of work today, along with its workforce, has changed. Asking people to take part in deciding the goals that they will be a part of is an essential component to engaging employees.

4. Are you communicative?

A leader’s ability to communicate is certainly a prized skill. The

greatest investor of our time, Warren Buffett, remarks that investing in developing your communication skills -- both in writing and in-person – “can increase your value by at least 50 percent.”

There is a difference between being a good communicator versus being communicative. When you’re communicative, you relay information consistently and clearly, in a way that makes you heard and understood. Being communicative may also mean over-communicating a strategy or vision clearly and consistently over and over again. The message amplifies the why behind the work, brings shared direction to all teams, and allows everyone to focus on what really matters.

5. Do you lead with love?

Before you roll your eyes, love, in this case, is a verb packed with action behind it to help people flourish and businesses profit on a human level. According to Brian Paradis, author of Lead with Imagination and former president of Florida Hospital’s (now Advent Health) Central Region, love was one of the guiding forces he saw transform the interactions within his teams.

“Love is powerful and when you infuse it into anything, that thing gets better,” Paradis told me in an interview. He added that while love is often viewed as a soft skill in the often harsh, transactional business environment, “the concept should be hard-wired in day-to-day interactions and strategy meetings.” By leading with actionable love and compassion, leaders set the tone of engagement within their businesses.

My thoughts... if we think of these 5 questions in terms of our Grange instead of a business they should still apply. I believe we as Grangers act with the “greater good” foremost in our minds. The above points can help with our success.

Your State Grange Staff have been busy printing, mailing, and getting items into the hands of each Grange for the past two months. Despite being down a staff member, the remaining staff have picked up the pieces to accomplish the necessary tasks. This has included learning new computer programs, operating office equipment, proper mailing procedures, and a variety of other tasks.

We updated our database to reflect current Grange officers, something that hasn’t been done for several years. The printed membership lists for each Grange have been revised to be easier to read. The Grange Secretary Handbook and report forms have been completely revised. Personally, I worked to create the new Grange Master/President Handbook and the Treasurer Handbook/Financial Guide.

Each Grange Secretary received a mailing from the State Grange office that included:

- Secretary Handbook
- Community Service Packet and Report Form
- Membership Packet
- Chaplain’s Memorial Service

However, the additional weight increased the postage so much that we sent them out separately. By mailing separately, we saved nearly \$3 in postage for each Grange.

We also sent out the proceedings from our 2020 State Grange Business Meeting in October. Some Granges received two copies in error. In future years, each Grange will receive one copy. Hopefully you will put the proceedings in a binder and have them at your Grange hall for reference at future meetings.

In the past two weeks, we have completed the annual update of the State Grange Legislative Policy Handbook. We do have a few printed copies, but it is also available on the State Grange website: www.wa-grange.org.

The New Member Packets have been completed and the first set of packets mailed out to those designated on your New Member Reports. We made revisions to the “New & Potential Member Handbook” and retitled it “New Member Handbook”.

The Grange Membership Application was divided into an Individual Member Application and a Family Member Application to eliminate confusion. The fourth degree membership pledge is now printed on the application, per the direction of the delegates at the 2020 State Grange Business Meeting. It is still required that applicants attend a meeting to take the pledge, but at least now they will know in advance what they are agreeing to.

Our goal is to post all the updated materials on the State Grange website. We hope to have the outdated materials removed this month and to replace it with the updated items.

In the next few weeks, the State Grange Executive Committee will be meeting via zoom to review the status of this year’s State Grange Session, currently scheduled for June in Port Townsend, and our Summer Junior Grange Camping Program. Let’s hope for a productive summer and a safe resumption of Grange activities across the state!

Legislative

First Major Milestone Of The Legislative Session Passed

The legislative session has passed the first major milestone. Any bill that did not pass its policy committee is now dead. Of course, nothing in the legislative process is that simple. Bills with significant financial consequences are exempt from cutoff and dead bills can come back to life if leadership wants them to.

State revenue has continued to grow during the pandemic. State revenues are expected to climb an additional 7% over the next two-year budget period under the current tax system. Even so, numerous proposals for new taxes have been put forward including an income tax on capital gains, a wealth tax, an increased estate tax, a carbon tax and a tax on health insurance.

This week, Senate Republicans released a 2021-23 budget proposal aimed at restarting schools and bringing jobs back, while saving money for lower-income families. Since Republicans are in the minority, we will have to wait and see if the majority party uses any of the ideas put forward. The majority party budget proposal is not expected for several weeks.

Highlights of the Senate Republican plan include:

- More than \$1 billion aimed at encouraging school districts to get children back into classrooms, of which \$200 million will go toward safety measures;
- \$333 million in additional assistance for small employers;
- More support for behavioral health;
- \$200 million to support efforts to expand broadband access;
- Eliminating the business-and-occupation (B&O) tax on manufacturing;
- Gradually shifting tax revenue from vehicle sales for use on transportation projects; and
- Full funding for improving forest health to reduce catastrophic wildfires.

In addition to new taxes, the cost of doing business in Washington could increase due to increases in the cost of fuel from the low carbon fuel standard moving through the legislature. Increasing the cost of fuel increases the cost of all goods due to transportation.

There are several unique bills this year. HB 1395, ensuring equity in farming, states its intent as ensuring opportunities for historically underrepresented groups to enter and remain in the farming industry. The bill directs the Washington State Department of Agriculture to report to the legislature by October 31, 2022, on progress, gaps, and recommendations to improve outreach to and resources for historically underrepresented farmers and ranchers.

House Joint Resolution 4205 would add a new section to the Washington State Constitution regarding the conservation and protection of the state’s natural resources. It would have the Constitution state that the people of Washington have the right to a clean and healthy environment, that the state shall serve as trustee of the natural resources of the state, and that the state shall equitably protect these rights for all people. It has sparked concerns about private property rights. Constitutional amendments require a 2/3s vote of both the House and the Senate as well as a vote of the people, so the road ahead is long.

Remember, the virtual legislative session this year has made it easy to participate from the comfort of your home. All legislative hearings can be seen online on TVW. You can watch live or go to www.TVW.org and watch the video anytime. You can also testify and/or submit written comments from your computer. The legislature’s home page, <https://leg.wa.gov/>, shows the daily calendar and has numerous links to help you find more information about your legislators and bills.

Grange Month Display Contest: "Cultivating Connections In Our Community"



Granges are encouraged to toot their own horn and the horns of other Granges as we celebrate Grange Month in April. The State Grange Membership Department is having a Grange Month Display Contest to assist in promoting the Grange and portraying the positive influences the Grange has made on our state and nation.

For over 130 years the Washington State Grange has worked to make our state a better place for our citizens. We are active in 226 communities throughout the state, providing a wide range of services and offering multiple activities and programs. A public display on our Grange programs will assist in informing the citizens of our state of our programs and achievements.

Grange Month is celebrated in April. We ask that each Grange create a public display to promote the Grange and to focus on the positive impacts the Grange has made in our state.

General Guidelines:

- Each Grange will arrange for their own display area in a prominent public location in their community. The display area may be a window, table, showcase, or whatever is available for use in your community.
- Each Grange will design a display featuring their projects and activities, with a focus on the positive impacts they have had on the community or state.
- The display should follow the theme "Cultivating Connections IN Our Community".
- A wide variety of Grange programs should be represented (i.e. lecturer programs, community service, youth activities, junior programs, family living, legislative etc.)
- The display must be in place for a minimum of seven days during the month of April.
- Each display must include a Grange logo and contact information for the local Grange.

Contest Information:

- Each Grange is encouraged to take a 3-5 pictures of their display (including one of the complete display).
- Place the pictures in a folder and include a 300-word (maximum) essay describing the display and what you tried to portray.
- Include your Grange name and contact information in the folder.
- Send the folder to the State Grange Office no later than May 1.
- Pictures of the displays will be used for promotion in The Grange News. In addition, pictures will be displayed at the State Grange Convention.
- Judging will be completed by a committee and will be based on: originality, creativity, design, and overall impact.
- Cash prizes will be awarded to the top five displays: \$50, \$40, \$30, \$20, and \$10.

All entries should be placed in a folder and sent by May 1 to the Washington State Grange, PO Box 1186, Olympia WA 98507. All entries will be available for pick up at the State Grange Convention.

Resolution Writing Tips

Resolutions are not hard to write!

One of the real benefits of membership in the Grange is the opportunity that membership gives to every Grange member to have an effective voice regarding the issues that affect their lives. Each of the National and Washington State Grange policy positions all started as resolutions that were written and adopted by a local Grange.

Even so, some people are still intimidated at the idea of writing a Grange resolution.

As the state Grange is scheduled to hold its annual convention this June, we hope it will help generate greater interest in grass-

roots participation in our Grange legislative program. The postmarked deadline for submission of resolutions from Subordinate and Pomona Granges is May 25.

Here is a quick and easy overview of writing a resolution:

Title of Your Resolution Here (This should be just a few words and easily summarize what the resolution is about)

Whereas, this is where you identify one problem that needs to be addressed or solved; and

Whereas, only place one reason or fact that supports your argument in each whereas paragraph; and

Whereas, only put facts in the whereas paragraphs that

make it easier for the reader to understand the purpose of your resolution; Therefore, be it


Resolved, that this is where you clearly state the primary action that you propose to solve the problem you identified in the whereas paragraphs (Resolved should stand alone from the Whereas’ as this will be the policy printed in the Legislative Handbook. No information from the Whereas’ will be printed in the handbook), and

Be it Further Resolved, that any secondary actions to address the problem are placed here.

Be sure to include both the Master and Secretary signatures, Grange seal, contact information and any supporting materials.

Lucky Mint Brownie Perfection

This is the perfect recipe just in time for St. Patrick’s Day. It’s a fun combination of mint and sweet chocolate that’s sure to have almost anyone’s taste buds screaming “yum.” This dessert might just be the pot of gold at the end of your rainbow this year.

These Mint Brownies have three delicious layers. First, a supreme brownie on bottom. Then a fluffy, green mint layer that’s full of flavor and color. Last, but definitely not least, a chocolate layer on top made with chocolate chips, butter and a little whipping cream.

All of these layers create a smooth, sweet, minty, bite-sized dessert perfect for any occasion, but especially St. Patrick’s Day. The green mint color really pops off the plate, giving it some extra flare and an appetizing glow.

Mint Brownies

Servings: 9-12

Ingredients:

Nonstick cooking spray
1 box supreme brownie mix with chocolate syrup pouch
3 tablespoons water
1/3 cup vegetable oil
1 egg

Filling:	Topping:
3 1/2 cups powdered sugar	1/2 cup whipping cream
1/4 cup butter, softened	1 bag (12 ounces) chocolate chips
1/4 cup whipping cream	1/2 cup butter
5 ounces cream cheese, softened	
1/2 teaspoon peppermint extract	
5 drops green food color	

Heat oven to 350 F. Spray 8-by-8-inch pan with nonstick cooking spray. In large bowl, mix brownie mix, water, oil and egg until combined. Pour into prepared baking pan. Bake 35 minutes. Cool completely, about 1 hour.

To make filling: In large bowl, beat powdered sugar, butter, whipping cream, cream cheese, peppermint extract and food coloring. Spread over cooled brownies. Refrigerate 1 hour, or until set.

To make topping: In saucepan, melt whipping cream, chocolate chips and butter until smooth. Cool until lukewarm, about 10 minutes. Pour over filling; spread to cover. Refrigerate 2 hours, or until set.

Before serving, let brownies set 10 minutes at room temperature.

Tips: Cut brownies with wet knife for cleaner cuts. Store covered in refrigerator.

The Youth Department has a few updates to bring to your attention. Many of the changes were made in 2020, but the pandemic is delaying the implementation until this year.

The Western Regional Grange Leaders and Youth Conference is still on schedule for August 6-8 in Boise, Idaho. Candidates for National Grange Youth Ambassador must attend the Regional Youth Conference this year and must participate in the conference with a prepared speech. There will be a separate class for youth ambassador candidates.

Candidates for the National Grange Youth Officer Team must participate in either the prepared speech contest or the impromptu speaking contest at the regional contest.

The Youth Achievement Awards have been replaced by the GRANGE Pillar Project. The report for the Pillar Project is include the details of what was planned, implemented, and the final result of conducting the project. The Youth Department is also sponsoring a display contest this year. The goal of this contest is to create either a digital or folding display that could be utilized at a county fair, library, Grange open house or other forum to promote the Grange, a Grange forum, or a Grange issue. If a static display is created, it should be brought to the State Grange Convention. If a digital or electronic display is created, it should be emailed in before the convention. This year's public speaking contest will have a new category. The radio spot is no more and has been replaced by a "Grange Commercial". A Grange commercial is an advertisement promoting the Grange. Prior to the State Grange Convention, the participant must film and edit themselves doing a commercial for the Grange. The commercial can include up to five people and should last between 30 and 60 seconds. The participants must include a written script. Commercials may be emailed in prior tot he convention to davona1242@outlook.com or may be turned in on a flash drive prior to the opening of the State Grange Convention to the State Youth Director. Note: there is a category for 36 years and over in this contest, thus non-youth Grangers are invited to participate.

The changes in these contests signify the emphasis on Grange promotion and the leadership development opportunities we hope to promote to our youth members.

Let's work to increase our participation levels in all our youth programs this year!

Lola is a much-loved member of Skookumchuck Grange #584 and Thurston County Pomona Grange #8.

In Memoriam

Richard "Rick" Nelson - Past State Grange Executive Committeeman

Richard "Rick" Nelson, age 68, passed away January 15, 2021 at his home. He was born on August 6, 1952 to Elna and Jim Nelson at St Peter's Hospital. He died in the house that he lived in his entire life.

Rick graduated from Tenino High School in 1970. He attended Centralia Community College and Washington State University where he earned a degree in agriculture and was a member of the Alpha Gamma Rho fraternity. He then returned home to help run the family farm, Nelson Ranch, one of the oldest ranches in the county still owned by the original family. He was a fourth generation descendant of early Thurston County pioneers.

Rick was a consummate storyteller. Anyone who knew him probably heard stories about a guy he nicknamed Bull or his friend he called Deputy Dog. Rick would often be laughing so hard that he couldn't even finish the story. He also enjoyed sharing tales he had learned from older local people about their experiences. One of Rick's greatest joys was his border collies. One of his favorite sayings was "Don't you wish you had a good dog like..." where he would fill in the blank with his dog's name. On Fridays you would typically find him attending the Chehalis Livestock Auction.

He was a passionate advocate for our community and agriculture. Rick was the current Pomona (Thurston County) Grange Master, a past Washington State Grange Officer, past Chairman of the Agriculture Committee for Washington State Grange, and a member of Brighton Park Grange for 55 years. He was President of the Thurston County Farm Bureau and a past President of the Washington State and Thurston County Cattlemen's Association. He served on the Puyallup Fair Rodeo Committee and the Washington State Beef Commission. He testified before the Thurston County Commissioners and state legislature many times. And was a regular attendee at hearings for the legislative farm committee and always helped serve beef to thousands of legislators and staff at the annual "Beef on the Hill" event. In 2000, Rick was named one of the top 25 leaders in Agriculture by the Livestock Market Digest.


Rick had a great smile. He loved to tease others by calling them an "old codger" even if they were just a few months older or younger than him. He loved Tenino vs. Rochester banter and enjoyed saying things like he could enter the Olympics for fencing because he could build fences better than the next guy. He was quick witted and had a good sense of humor. He always seemed to one-up others and enjoyed being known as "Rodeo Rick" and as "the only true cowboy" at the Valley Athletic Club. Many who knew him from the Valley have commented that they enjoyed talking to him between work-outs or sticking around after their work-out to hear his stories.

In addition to helping run the family farm, Rick was an auctioneer. He was proud of his fast talking verbiage and his ability to auctioneer. He volunteered his services each year for the Thurston County Market Animal Sale, a livestock auction for Thurston County youth; the Tenino FFA auction, the Thurston County Fair Auction to keep the fair soluble; the Tenino Splash Bash, an auction to keep the Tenino historic pool open; and the Thurston County Cattlewomen's auction whose proceeds funded scholarships for local youth. He was also the announcer for the Tenino Oregon Trail Days parade and 2019 Tenino Chamber Volunteer of the Year. He embodied real community spirit and would do anything for the town of Tenino. Anyone who attended any of these events probably heard him say, "Tenino is the center of the known universe."

Rick is survived by his siblings, Virginia "Ginny" and Ray Nelson, Ronald "Ron" and Kay Nelson; nephew, Scott Nelson; nieces, Jill Nelson, Karen Nelson, and Anna Nelson; and grandnieces/nephews: Naomi Nelson and Elias, Tycho, and Camille Barry.
